Preface

Purpose and Scope

The purpose of this Recommended Practice is to offer guidelines for procedures to file a complaint to the Towing and Recovery Board within the State of Arkansas.

This Recommended Practice establishes the procedure for filing a complaint with the Towing and Recovery Board within the State of Arkansas. Use of this RP will enable you to file a complaint on a Towing and Recovery business.

Complaint Filing Guidelines

A person must obtain a copy of the complaint form by either going to the Arkansas Towing & Recovery Board web site, or by print the attached Complaint Form. Once the form as been completed in full, and accompanied with a written statement with all the details of the complaint and any copies of supporting information (ex. Copy of letters, bills, impound ticket, etc.) The plaintiff should then submit the document to:

Procedure of Board

Once the Complaint Investigator receives documentation of the issue, that Investigator will then contact all parties and try to resolve the case by phone prior to the next meeting of the Arkansas Towing & Recovery Board.

If resolution is not obtained, the Board reviews the case, State's evidence is given by investigator, and then the plaintiff states their case to the Board. The Board then decides on judgement.
