## <u>Presentation - Topic: Training Opportunities Offered by Advance Online Solutions</u>

#### **Question & Answer / Points**

Q: Who has access to the data from individuals who participate in your program? A: The data is restricted to your company. We do provide to DOT the numbers of courses completed each month. But we do not provide any information on a company or an individual.

Q: How is the material completed graded? Is it pass, fail, and/or retrain?

A: Our standard is 70% for passing. A person can review the questions missed for the correct answers. If a person fails, they can be retested on areas missed. A new series of questions will be used for any one requiring retesting. The system only has the capability to retest three times before the individual would have to start from the beginning again.

Q: Are there 3 charges if a person fails 3 times?

A: No. Billing is based on the size of the company and the number of courses desired during a training cycle.
