- Compliance Review Process
 - Opening Interview

 - Financial Responsibility 49 CFR Part 387
 - Maintenance Review 49 CFR Part 393 & 396
 - Commercial Drivers License, Controlled Substance Testing and Driver Review 49 CFR Part 382, 383, 391 & 392
 - o Hazardous Materials 49 CFR Part 171-180
 - Hours of Service Review 49 CFR Part 395
 - Close Out Interview
- As a result of the Compliance Review, the carrier will be issued a safety rating of:
 - Satisfactory
 - Conditional
 - Unsatisfactory
- As a result of CSA 2010, the carrier will be issued a Safety Fitness Determination (SFD) of:
 - Continue to Operate
 - Marginal
